



# Wangaratta Festival of Jazz & Blues Sunday Market

## Terms and Conditions

Sunday 4<sup>th</sup> November 2018

1. The Wangaratta Festival of Jazz Sunday Market coordinator reserves the right to reject any application. Payment of site does not guarantee acceptance;
2. Goods sold at the stall must be those that were submitted on the application form only;
3. Stall holders may set up from 5.30am on Sunday ensuring ready for trading from 9am-3.00pm;
4. **All vehicles must be removed from market sites at 8.00am and will not be allowed back on site till 3.30pm;**
5. Stall holders will not permit any other person/business to occupy their site;
6. The stall holder must hold Public Liability Insurance cover (to the value of \$10 million) indemnifying the organisers and members of the public against accident. The organisers reserve the right to inspect a Certificate of Currency;
7. Product Liability Insurance is the responsibility of the stall holder. The stall holder indemnifies Wangaratta Festival of Jazz & Blues from any claims or loss arising from sale of stall holder products;
8. The stall holder needs to ensure that their site is safe and without risk to the health and wellbeing of the stall holders, stall holder's employees and other persons who may come upon the site. The stall holder takes full responsibility while alleviating any liability towards the festival, festival staff and volunteers;
9. Stalls using marquees must be secured or weighted down at all times (i.e. sand weights);
10. The stall holder must give the Market Coordinator permission to use their images, business name and website text for market promotional use;
11. Food stall holders must be registered with Wangaratta's local council and have appropriate insurance and licences;

12. Stall holders requiring power must stipulate at the time of submitting their application along with the required amps needed as power is not available in every area of the park with no electrician on site on the day;
13. All electrical equipment and lead must be tested and tagged;
14. Stall holders using gas must submit a Gas Checklist prior to market day;
15. Stall holders are responsible for leaving their site and surrounding area clean and tidy as they found it. Rubbish is to be stored and removed at the end of the day as all bins onsite are for patron use only;
16. Wangaratta Festival of Jazz market accepts no responsibility for adverse weather therefore, no refunds will be given for this reason;
- 17. No refund will be given for cancellations if notice is given no less than 4 weeks prior to market date;**
18. The organisers will not be liable for loss or damage to the stall holder's property whilst en route or on site;
19. Stall holders will treat patrons, Market Coordinators and volunteers with courtesy and expert Fair Trading practice consistent with Consumer Law.;
20. Stalls are allocated at the discretion of the Market Coordinators and is final with no discussion being held on the day;
21. Stall holders must comply with all instructions by Market and Event Staff.
